

ORDINANCE NO. _____

AN ORDINANCE ENTITLED THE ANNUAL APPROPRIATION ORDINANCE FOR FISCAL YEAR BEGINNING OCTOBER 1, 2020, APPROPRIATING THE SUM OF \$832,500. TO DEFRAY THE EXPENSE AND LIABILITIES OF THE CITY OF RICHFIELD FOR SAID FISCAL YEAR. AUTHORIZING A LEVY OF A SUFFICIENT TAX UPON THE TAXABLE PROPERTY AND SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH SAID APPROPRIATIONS IS MADE.

BE IT ORDAINED BY, the Mayor and City Council of the City of Richfield, Lincoln County, Idaho.

SECTION 1. That the sum of \$67,000. be and the same is appropriated to defray the necessary expenses and liabilities of the City of Richfield, Lincoln County, Idaho, for the FY beginning October 1, 2020.

SECTION 2. The objects and purposes for which sum appropriation is made and the amount of each object and purpose is as follows:

SECTION 3. That a general tax levy on all taxable property within the City of Richfield, be levied in an amount by law for the general purpose for said City, for the FY beginning October 1, 2020.

SECTION 4. All Ordinance and part of Ordinances in conflict with this Ordinance are hereby repealed.

Section 5. This Ordinance shall take effect and be in full force upon its passage, approval and publication in one (1) issue of the Courier News, a newspaper of general circulation in the City of Richfield, and the Official Newspaper of the said City.
